# Competitor Licence Application

**Licence Testing:** Licence testing is compulsory for all first time Junior & Senior applicants. This can be completed through your club.

**Mini Licences:** For all junior non competitive licence holders. This can also be used for participants 4 to 15 years of age who are solely competing in Minikhana

**Junior Licences:** May be issued to riders aged between 7& 15 years.

**Senior Licence:** May be issued to riders who are 16 years or older.

**National Licence:** Valid for practice days, Club, Interclub and Open meetings.

**Club Licence:** Used for practice days, Closed to club and Inter club meetings.

**Restricted National Licence:** For riders who only competing in Moto Trials, Mini Moto or Fast 50's

**Recreational:** For riders 16 years and over – this licence cannot be used for racing.

**Supercross:** Must have a national licence and pass a Supercross school conducted by a level 2 or higher coach. Only for 12 years and above.

**Quads and Sidecar Passengers:** Must complete a further discipline practical and theory test with a MNSW Testing officer

**Speedway:** Must be a National licence and have completed the speedway theory and practical test. Only for 9 years and above.

**Junior Road Race:** Must have licence endorsed by a MNSW Junior Road Race assessor. Only for 13 years and above.

**Entrants:** A person or corporate body must have this licence to enter a rider in any competition.

**One Event National:** Valid for Historic events only. Availability will be stated in the events supp regs.

**ONCE A LICENCE HAS BEEN PROCESSED A FULL OR PART REFUND WILL NOT BE ISSUED.**

## PROHIBITED SUBSTANCES
